## Wednesday, May 20, 2015

The second regular meeting of May, 2015 of the Pike County Commissioners was called to order by Commissioner Caridi at 9:00 a.m. at the Pike County Administration Building, followed by the "Pledge of Allegiance" to the flag.

**PRESENT:** Commissioners Caridi and Osterberg; Chief Clerk Orben; Solicitor Farley.

**NOT PRESENT:** Commissioner Wagner.

Public Comments/Questions concerning today's agenda.

Items #1 and #2 under New Business was moved to this point in the meeting.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Caridi, to adopt Resolution No. 15-12, Approving the Creation of the Pike County Tick Borne Diseases Task Force as a County Committee, which was read by Commissioner Osterberg.

**VOTE:** Commissioners Caridi and Osterberg voted 'aye'. Motion carried.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Caridi, to appoint the following to the Pike County Tick Borne Diseases Task Force: Clare Bennett, Jim McCaw, Sandy McCaw, Jeff Rosalsky, Marty Theys, Mikki Weiss, Matthew M. Osterberg and Robert A. Ollar, PhD.

Mikki Weiss expressed her personal appreciation and gratitude to the Commissioners for creating this task force. Ms. Weiss gave a history of her efforts to educate the public regarding these terrible tick borne diseases. Ms. Weiss said that more funding is needed for this education process. Other members of the task force also made comments regarding this topic and their concerns. The Commissioners stated that the education will be spread to road masters of the townships; and also suggested that the Penn State Cooperative Extension and the Conservation District may be able to offer assistance and input.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Caridi, to advertise for bids for the sale of the following vehicles: 2006 Ford Crusader Bus, wheel chair accessible, 9 passenger, VIN #1FDWE35S56DA88492, with 207,341 miles, AS IS, for a minimum bid of \$2,500; and a 2006 Ford Crusader Bus, wheel chair accessible, 9 passenger, VIN #1FDWE35S26DA47163, with 189,667 miles, AS IS, for a minimum bid of \$2,500.

Carl Wilgus, Executive Director of the Pocono Mountains Vacation Bureau, explained that the MOU is for the PMVB to fill in as staff support to the Hotel Tax Board, a role that was filled by Bridget Gelderman for the past 5 years. The Hotel Tax Board will function in the same way with finances. He suggested a letter of appreciation to Bridget Gelderman for her role as one person doing all the staff responsibility. Keith Williams, who runs the Visitors Center in Lake Wallenpaupack, will be their key liaison with the Hotel Tax Board, and he will have 24 people working to support that effort. This was done by one person, Bridget Gelderman, previously. With the changing dynamics of tourist marketing, Pike County will be better served and more effective in getting much of the work accomplished. Mr. Wilgus also distributed a handout that will be in hotels and resorts throughout the Pocono Mountains focused to the business traveler, the vacationer to look at the Pocono Mountains as a leisure travel vacation site, but a please to start a business in this region.

Commissioner Osterberg stated that Bridget Gelderman will continue to be on the Hotel Tax Board but some of her duties will be provided by the PMVB. Discover Pike, the Vacation Guide, the website and any of the social media activities will be provided by the PMVB by tapping into their existing resources.
