Communications Center Director Bernie Swartwood explained that a Communications Operability Trailer will be provided through Homeland Security funds for the 8 region task force in the Northeast. Each county will be getting a trailer or will be modifying their existing large communications type vehicle. The contract with CellularOne is for wireless service for this trailer.

MOTION: by Commissioner Wagner and seconded by Commissioner Hummel, to execute the FY 2011-12 Contract for Professional Services between Northwestern Human Services and the County of Pike, on behalf of Children & Youth Services.
