The first regular meeting of September of the Pike County Commissioners was called to order by Commissioner Caridi at 9:00 a.m. at the Pike County Administration Building, followed by the "Pledge of Allegiance" to the flag. An opening prayer was offered by Tim Sheare of the Lost & Found Bible Church.

PRESENT: Commissioners Caridi, Hummel and Wagner; Chief Clerk Orben and Solicitor Farley.

Sheriff Bueki presented Life Saving Medals to Pike County Sheriff Deputies Wesley Vigh and Daniel Parks for an incident involving an individual bitten by a rattlesnake in Greene Township.

Letters of Appreciation were presented to Staff Sergeant Timothy Flaherty and First Sergeant Edward Hammond, who just came back from Iraq.

Public Comments/Questions concerning today's agenda.

Representatives of PPL, PCL&P and MetEd were present to update the County on the restoration of power. Meetings will be held shortly with emergency services, municipalities and power companies to determine where the County stands as far as these storms are concerned, and how to better communicate on power outage time estimates, and notifications to local municipalities. Many without power also went without phones and internet and were unable to prepare for the lengthy outage.
