## **MISCELLANEOUS:**

Commissioner Osterberg highlighted a letter from McGoey, Hauser & Edsall, County Engineers, regarding the potential costs of expanding the proposed court addition to the rear of the building. The difference in real estate between the Keystone Building and the Judge's Annex is \$490,000; the minimum of \$400,000 to \$600,000 or more to relocate the Verizon lines; \$98,000 to relocate the Orange & Rockland power lines in a similar manner to Verizon; to configure the building would add another \$240,000; for a total of \$1,328,000. This does not include Blue Ridge Cable, natural gas line relocation, differences in building demolition costs, potential conflicts with existing septic systems, etc., as they currently remain unknown. As stated in the last meeting in November, no business would make a decision to buy a lot in the Borough for nearly \$1.4 million. It is sad that the building may be demolished, but Commissioner Osterberg stated that hopefully someone will come forward and move it. It can be moved within the District of the Borough.

Jim Pedranti, Chairman of the Board of Directors of the Greater Pike Community Foundation, presented a brochure on the new entity. The purpose of this entity is to provide the community with philanthropy for maximum benefits to the donors. Community foundations enable donors to pursue their charitable objectives while realizing the best tax benefits allowed by law. The Greater Pike Community Foundation's service area encompasses the entire Pike County region. Mr. Pedranti gave an overview on the foundation and its programs.
