**VOTE:** Commissioners Caridi, Osterberg and Wagner voted 'aye'. Motion carried.

**MOTION:** by Commissioner Osterberg and seconded by Commissioner Wagner, to approve the June 19, 2013 Commissioners' Meeting Minutes.

Commissioner Osterberg announced that effective yesterday, Pike County Emergency Management Office created a Facebook page to disseminate emergency information to residents. Most people want to have social media as a way to be notified in the event of road closures, weather alerts, emergencies, etc. Commissioner Osterberg requested that the press place the Facebook page "Pike County Emergency Management" in their article. The page does say that in an effort to communicate with residents, the EOC and the County Commissioners' Office have created this Facebook page. The page has been developed to assist area residents during County emergencies. The page will show weather emergencies, road closures and other events that will affect the County. Commissioner Osterberg also asked that people on Facebook share and like this page with their friends. This is another step toward better communication.
