PROPOSED CONSTITUTIONAL AMENDMENT BALLOT QUESTIONS

Article III, Section 9

RELATING TO TERMINATION OR EXTENSION OF DISASTER EMERGENCY DECLARATIONS

Shall the Pennsylvania Constitution be amended to change existing law and increase the power of the General Assembly to unilaterally terminate or extend a disaster emergency declaration-and the powers of the Commonwealth agencies to address the disaster regardless of its severity pursuant to that declaration- through passing a concurrent resolution by simple majority, thereby removing the existing check and balance of presenting a resolution to the Governor for approval or disapproval?

DISASTER EMERGENCY DECLARATION AND MANAGEMENT
